6a. Discuss minimum cash balance for the District

The Board needs to consider the cost of buying a new engine? New or used? Cost? Chief Joyce estimates a new engine would cost about \$250,000. The City would buy 4613 for about \$50,000, which would offset our District's expenditure.

The Board is also faced with the cost of an exhaust system for the station. Chief Joyce said we will be seeking a grant for this.

Director Kliewer suggested the Board set a minimum cash limit at the November Board meeting after the Chief has a chance to price a new engine while Chairman Ashworth is still on the Board. Currently, the Board is considering an undeclared minimum of \$400,000.

Chief Joyce brought up a situation being created by Supervisor Ed Valenzuela referring all inquiries/complaints regarding campfires around Lake Siskiyou to the District. This is CalFire's jurisdiction, not ours. Chief Joyce and Chief Melo have been inundated with calls and emails regarding this issue. The Board requested Chief Joyce to write an email to Supervisor Valenzuela explaining this and asking him not to refer anyone to the District on this.
